

## **SCHEDULE OF RENEWAL ANNOUNCEMENTS**

A. **Pre-Filing Announcements.** Notice of the forthcoming filing of the license renewal applications for radio stations KCRW, KCRU, KCRY and KCRI must be broadcast at least once a day on June 1, June 16, July 1, and July 16, 2013.

At least two (2) of the required announcements must be broadcast during drive time (*i.e.*, between 7:00 – 9:00 a.m. and/or 4:00 – 6:00 p.m.). The remaining pre-filing announcements may be broadcast at any time, in the licensee's discretion, on the scheduled days.

B. **Post-Filing Announcements.** Notice that the license renewal applications have been filed must be broadcast at least once a day on August 1, August 16, September 1, September 16, October 1, and October 16, 2013.

At least three (3) of the required announcements must be broadcast during drive time (*i.e.*, between 7:00 – 9:00 a.m. and/or 4:00 – 6:00 p.m.). The remaining post-filing announcements must be broadcast on the scheduled days in each of the following time periods: (a) at least one between 9:00 a.m. and 12:00 noon; (b) at least one between 12:00 noon and 4:00 p.m.; and (c) at least one between 7:00 p.m. and 12:00 midnight.

## **PRE-FILING ANNOUNCEMENT**

On January 12, 2006, November 29, 2005, November 29, 2005, and July 13, 2007, KCRW, KCRU, KCRY, and KCRI, respectively, were granted licenses by the Federal Communications Commission to serve the public interest as public trustees until December 1, 2013.

Our licenses will expire on December 1, 2013. We must file applications for renewal of our licenses with the FCC by August 1, 2013. When filed, a copy of the applications will be made available for public inspection during our regular business hours. Individuals who wish to advise the FCC of facts relating to our renewal applications and whether the stations have operated in the public interest should file comments and petitions with the Commission by November 1, 2013.
